

iDrink Ambassador Agreement

This Ambassador Agreement (“Agreement”) is entered into by and between **iDrink, Inc.** (“Company”) and the participating individual (“Ambassador”), and shall become effective upon the Ambassador’s acceptance through the Company’s designated platform.

1. Independent Contractor Relationship

The Ambassador acknowledges and agrees that:

- This Agreement does not create an employment, partnership, or joint venture relationship.
- The Ambassador is an independent contractor and is solely responsible for their own activities.
- Participation in the program is voluntary and may be terminated by either party in accordance with this Agreement.

2. Enrollment and Participation

- Participation in the Ambassador Program may require:
 - A one-time onboarding fee of \$99; and/or
 - A recurring monthly fee of \$9.99.
- All fees are non-refundable.
- Commission eligibility is subject to a thirty (30) day qualification period from the date of enrollment.

3. Ambassador Responsibilities

The Ambassador agrees to:

- Actively promote iDrink services to both consumers and businesses.
- Generate and support:
 - Business partnerships (including bars, restaurants, and events)
 - VIP memberships
 - Platform engagement and transactions
- Represent the Company as a brand ambassador in a professional manner.

- Conduct outreach through:
 - In-person engagement
 - Social media and digital platforms
 - Direct referrals and networking
- Use only official Company-provided tools, links, and marketing materials in an appropriate and authorized manner.

4. Compensation Structure

The Ambassador understands and agrees that:

- Compensation is strictly performance-based.
- Earnings may be generated through:
 - Partnerships
 - VIP memberships
 - Transactions
 - Renewals
 - Eligible bonuses and incentives
- Commissions are earned only on completed and verified transactions.
- Payment eligibility begins after the thirty (30) day qualification period.

5. Team-Based Earnings

- Ambassadors may be eligible to earn override commissions based on:
 - Personal referrals
 - Team performance, subject to rank advancement
- Advancement and eligibility are determined by:
 - Active participation
 - Sales performance
 - Team growth and development

6. Bonuses and Incentives

Ambassadors may qualify for additional compensation, including but not limited to:

- Fast-start incentives during initial participation periods
- Performance-based bonuses
- Team milestone rewards

All bonuses and incentives are subject to the Company's qualification criteria and may be modified at the Company's discretion.

7. Compliance and Conduct

The Ambassador agrees to:

- Represent iDrink in a professional, ethical, and lawful manner.
- Refrain from making false, misleading, or unsubstantiated claims, including income guarantees.
- Comply with all Company policies, guidelines, and applicable laws and regulations.

The Company reserves the right to suspend or terminate the Ambassador's participation immediately in cases of:

- Misconduct
- Misrepresentation
- Violation of this Agreement or Company policies

8. Term and Termination

- This Agreement shall commence upon acceptance and remain in effect until terminated by either party.
- Either party may terminate this Agreement with thirty (30) days' written notice.
- The Company may terminate this Agreement immediately for breach, unethical conduct, or legal violations.

Upon termination:

- Access to Company systems, tools, and platforms may be revoked.
- Any unpaid or future earnings may be forfeited if qualification requirements are not met.

9. Earnings Disclaimer

The Ambassador acknowledges and agrees that:

- Earnings are not guaranteed.
- Compensation is based solely on individual effort and performance.
- The Company has not made any guarantees, projections, or promises regarding income.

10. Acceptance of Agreement

By completing the Ambassador registration process, the Ambassador confirms that they have read, understood, and agree to be bound by the terms of this Agreement, including all applicable policies, procedures, and compensation structures associated with the iDrink Ambassador Program.
